#### 2. HAZARDS IDENTIFICATION

<b>Health Effects:</b>	Prolonged and /or repeated contacts: Risk of skin sensitization. When handled at high temperatures, can cause serious burns.

**Ingestion:** Remove contact lenses after the initial 1-2 minutes and continue flushing for several additional minutes. If effects occur, consult a physician, preferably an ophthalmologist. If swallowed, seek medical attention. May cause gastrointestinal blockage. Do not give laxatives. Do not induce vomiting unless directed to do so by medical personnel.

#### 5. FIRE-FIGHTING MEASURES

**Suitable extinguishing media :** Water fog or fine spray. Dry chemical fire extinguishers. Carbon dioxide fire extinguishers. Foam.

If material is molten, do not apply direct water stream. Use fine water spray or foam. Cool surroundings with water to localize fire zone. Hand held dry chemical or carbon dioxide extinguishers may be used for small fires.

**Other information:**

##### 10. STABILITY AND REACTIVITY

<b>Reactivity:</b>	No dangerous reaction known under conditions of normal use.
<b>Chemical stability:</b>	Stable.
<b>Conditions to avoid:</b>	Avoid temperatures above 300 °C. Exposure to elevated temperatures can cause product to decompose.
